Final review of 1, 3, 5 year plan

- Change "weighted lottery" to "Increase socioeconomic diversity"
- Modify year 1 items to update those that are already accomplished
- Elizabeth suggested to remove percentages (10% in 10 years) and specific numbers (30 300M) to allow for strategic planning
- Question about Professional Development (PD) being on the 5 year plan and Evaluations being on the 3 year plan? PD & staff evaluation will both be on year 3

Updates & Strategic Planning

- JEDI (Justice, Equity, Diversity, Inclusion)
 - Encourage people to join and build community; meeting once monthly
- Student Involvement with DEI
 - Efforts are underway to survey interest and select students for committee input and other functions
- Strategic Planning & Fundraising

Academic scholarships

Discussion items:

- We have about 128 three and four year olds each year.
- Scholarships are being discussed in DEI, Policy and Development.
- We have a scholarship fund, going to continue to push this as a vision.
- Over the next two years we would raise enough funds to offer scholarships to 3 and 4 year olds.
- The state of NC changed lottery preference laws, and we're allowed to give already enrolled 3 and 4 year olds lottery preference. Lottery cohort this year is all new.
- Should consider that Before and Aftercare services will likely be needed by scholarship recipients.
