***A non-refundable/non-transferable fee is due with registration. A 2018-19 contract must be turned in prior to a student being allowed to attend the Before/Aftercare program. Students without a contract on file will be brought to the main office and parents will be contacted.**

This is an annual contract that is from August 20, 2018 until June 13, 2019. If for any reason a student withdraws or is required to withdraw after the start of the 2018-2019 academic year, *the monthly tuition is still due in full for the month of withdrawal (a 30 day written withdrawal notification is required)*. Re-entry into the program will require a new registration and re-entry cannot be guaranteed, as it is on a "space available" basis.

Payment is due by the first of each month. A late fee of \$25 per month is assessed by the 9th day each month if your account is past due. After 30 days, notification will be made that the account is in arrears. Payment in full is expected within 15 days of notification for the child to be eligible to continue in the program. Accounts past due by more than 60 days may be asked to withdraw from the program and will be sent to collections.
